The shares allotted to the ESOP Trust shall be allocated/transferred to the Eligible Employees upon Exercise of Options.

Further, the Committee has also approved the cancellation of 10,750 Options under Route Mobile Limited - Employee Stock Option Plan 2017 ('RML ESOP 2017') and cancellation of 5000 Options granted under Route Mobile Limited-Employee Stock Option Plan 2021 ('RML ESOP 2021').

Consequent to this allotment, the paid-up capital of the Company stands increased from Rs. 62,18,25,670 (consisting of 62,18,25,67equity shares of face value of Rs. 10 each) to Rs. 62,31,15,420 (consisting of 6,23,11,542 equity shares of face value of Rs. 10 each).
