The shares allotted to the ESOP Trust shall be allocated/ transferred to the Eligible Employees upon Exercise of Options.

Further, the Committee has also approved the cancellation of 3,750 Options under Route Mobile Limited - Employee Stock Option Plan 2017 ('RML ESOP 2017').

Consequent to this allotment, the paid-up capital of the Company stands increased from Rs. 62,31,15,420 (consisting of 62,31,15,42 equity shares of face value of Rs. 10 each) to Rs. 62,44,32,170 (consisting of 6,24,43,217 equity shares of face value of Rs. 10 each).
