For the above purpose, the shareholders are requested to update their PAN with their depository participants to get the benefit of lower TDS rate and to enable the Company to provide the TDS Certificates to the shareholders. ii) Non-resident Shareholder: TDS Rate @ 20% plus applicable Surcharge and Cess (OR) applicable Tax Treaty Rate under the Double Tax Avoidance Treaty (DTAA) between India and their country of residence (whichever is lower), subject to the fulfilment of the following requirements: The non-resident shareholders are requested to provide the following documents to avail the tax treaty benefits by sending an email to secretarial@lauruslabs.com on or before May 11, 2025: Declaration for "No Permanent Establishment" in India; Beneficial Ownership Declaration; Tax Residency Certificate (TRC) for FY 2025-26; Form 10F and Copy of Indian PAN (if available).
