- Revenue from operations stood at Rs. 1,119.42 crore as against Rs. 1,113.41 crore in Q2FY25
- Profit Before Tax and Exceptional items stands at Rs 137.87 crore as against Rs. 131.06 crore in Q2FY25

Earnings before Interest, Tax, Depreciation and Amortization (EBITDA) excluding Exceptional items stood at Rs. 135.95 crore for Q2FY26 as compared to Rs. 93.90 crore in Q1FY26. The company's EBITDA margin stood at 12.14%

Profit Before Tax and exceptional items stood at Rs. 137.87 crore for Q2FY26 as compared to Rs. 76.57 crore in Q1FY26. The company's Profit before tax and exceptional items margin stood at 12.32%

Profit Before Tax (PBT) stood at Rs. 2.00 crore for Q2FY26 as compared to Rs. 76.57 crore in Q1FY25. The company's PBT margin stood at 0.18%

Profit After Tax (PAT) reported at Rs. (18.83) crore for Q2FY26 as against Rs. 58.78 crore in Q1FY26.
