This is with reference to our intimation dated December 18, 2025 regarding allotment of 5,500 equity shares under Route Mobile Limited - Employee Stock Option Plan 2017 ('RML ESOP 2017').

We wish to inform you that the Nomination and Remuneration Committee has, by way of circular resolution on December 24, 2025, at 9:25 P.M. IST, has rescinded the earlier resolution dated December 18, 2025 and approved afresh the allotment of 5,500 equity shares under the 'RML ESOP 2017, effective December 24, 2025, upon receipt of exercise price consideration.
