Pursuant to Regulation 30 read with Schedule III, Part A, Para A, Sub-Para 20 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, Route Mobile Limited ("the Company") hereby intimates the following orders passed by the Employees Provident Fund Organisation ("EPFO") on Send Clean Private Limited, a wholly owned subsidiary of the Company ("WOS").

The above orders relate to alleged PF defaults pertaining to the period prior to Route Mobile Limited's acquisition of Send Clean Private Limited in September 2016 and pertain to the erstwhile employer/previous owner. Both orders have been stayed by CGIT vide orders dated 26-03-2026 (Appeal Nos. CGIT-1/EPFA/17/2026 & CGIT-1/EPFA/10/2026). Accordingly, no financial provision has been made, and no material adverse financial impact is expected.

The intimation is being filed with a delay as the orders were received at the subsidiary level and time was required for internal escalation and prima facie assessment of the disclosure obligation.

This intimation is being made in the interest of transparency and investor awareness. The Company will keep the Stock Exchanges informed of any further material developments in the above matters.
