Nature of Attack: Following the 24 June disclosure, the threat actor demonstrated continued persistence by re-establishing footholds through further post-exploitation activity and credential theft, culminating in a sustained campaign that abused unauthorized text-messaging capabilities using the compromised credentials. B. Remediation Status: CrowdStrike, Cypfer, and Norton Rose Fulbright are engaged directly with Masiv engineering to remediate all critical vulnerabilities and indicators of compromise (IOCs) identified in the CrowdStrike and Cypfer scan reports. Remediation is approximately 50% complete to date, with the remaining items actively in progress. C. Independent Audit Firm Involvement: Cypfer (DFIR) is leading forensic validation of IOC remediation and confirming eradication scope; CrowdStrike is conducting vulnerability scanning and will issue the closing security attestation; Norton Rose Fulbright is providing continuous legal oversight to ensure remediation activities align with notification and disclosure obligations. D. Governance Oversight & Next Milestone: Remediation progress is being tracked under centralized incident governance, with closure contingent on CrowdStrike's formal attestation letter — the milestone that will also determine the timing of the next round of stakeholder and regulatory communication.
